Junior Development Membership



- O.N.E. (Optimal Network Experiences) benefits may be added to this level of membership for \$62 a month.
- The entire family of the designated Junior Golfer(s) will enjoy full tennis, dining, social, fitness and pool privileges.
- Eligible dependents must be from the same family to receive the “two or more” junior rate.
- When eligible dependents exceed age limitations (19 years old and older), the membership may be converted to a different level or terminated without penalty.
- This special membership is open to Junior Golfers that are 18 years old and under only. Initial offering will be for 25 memberships only in this category (type code.)
- Golf access is available to the designated Junior Golfer(s) on the membership account anytime Tuesday through Thursday (course closed on Mondays), Fridays after 2 p.m., and after 12 p.m. on weekends and holidays.
- Golf driving range and practice amenities are available to the designated Junior Golfer(s) any time during the week and after 10 a.m. on weekends and holidays.
- Tee times are made on a space available basis through the Oak Tree pro shop – no more than 24 hours in advance (same day and walk-up play is welcome.)
- Valid drivers license is required to drive a cart.
- Parent may drive a cart for designated Junior Golfer (parent may not play golf.)
- Junior Golfer(s) may have guests on the golf course – standard guest policies and applicable fee applies.
- The monthly dues are subject to annual review and adjustment.
- The Application Fee is subject to change at any time.
- Sales tax applies to all applicable monthly dues and usage fees.
- Failure to abide by all standard Club rules and the special “Junior Golf Development Membership” rules may result in the suspension of club privileges or termination of membership without refund of any fees paid.
- Club Management reserves the right to amend the Junior Golf Development Membership Privileges and Usage Parameters as they may deem necessary.
- While a “temporary membership category,” the goal is to continue to have Junior Development Memberships available. Club Management will analyze and review the program annually and as needed on a go-forward basis.
- The parent(s) of the Junior Golfer(s) is considered the “primary Member” and has financial responsibility for all charges to the account.

Monthly Dues for one child: \$370 +tax
(Option to add O.N.E. for \$62 a month)

Quarterly Food Minimum: \$150
